This is a summary of the main features, benefits and limitations of the Insurance Policy provided by The New India Assurance Co Ltd for your business. Full details of the cover including entire terms conditions and exclusions are set out in your Insurance Policy.

Type of Insurance and Cover: The policy provides cover in packaged form for **Commercial Property Owners**. It is a non-investment insurance contract. Its duration is 12 months unless you and / or your Insurance Intermediary have arranged a different period with The New India Assurance Company Limited.

Basic Cover

- Buildings (including Inflation Provision)
- Landlord's Contents - £5,000 provided free of charge
- Fixed Glass, Sanitaryware and Signs
- Property Owner's Liability

Additional Options

- Loss of Rent
- Employer's Liability
- Legal Expenses (Arranged by ARAG - The Insurer is AmTrust Europe Limited)

Terrorism

Terrorism is excluded under the policy other than for Employers Liability

Should you require Terrorism Cover under Section 1 – Building and Landlord's Contents and Section 2 - Rent this can be provided in selected cases at an additional premium, which must be paid to New India within 30 days.

Terrorism cover is not available for risks in Northern Ireland

The Cost

The cost of the Basic Covers depends upon just four factors:

- The cost of rebuilding (Building Declared Value)
- The occupation of your Premises
- The value of your Contents and additional optional sections
- Where your Premises are situated

Average

If you do not insure for the full value of your premises, landlord's contents or rent any payments made under Section 1 and 2 will be proportionately reduced. Be sure to avoid this penalty by insuring for full amounts.

Excesses

You are asked to bear the first £250 of each claim for loss or damage under the following:

- Section 1 - Contents
- Section 2 - Rent

A higher excess based on location will apply to loss arising from Subsidence, Ground Heave or Landslip.

Significant and unusual exclusions or limitations

- Pollution contamination and seepage unless sudden and accidental
- Water table changes
- Shutters
- Minimum security conditions
- Intruder alarm may be required
- Cooking in bedrooms
- Housekeeping and maintenance conditions
- Electrical inspection condition
- Waste
- Portable heaters condition
- Unoccupied building condition
- Hot Work Permit
- Tenancy must be for a period of not less than 6 months
- Multi Tenure Properties
- Theft unless involving entry to or exit from the premises by forcible and violent means
- Cancellation condition
- Reinstatement of Sum Insured following a claim
- Felt Roof condition

For Employer liability, exclusion of offshore activities and limit of £5,000,000 arising out of Terrorism.

For Public and Products liability exclusion arising from Genetically Modified Organisms, asbestos, offshore activities, transmissible spongiform encephalopathy (TSE) (including bovine spongiform encephalopathy (BSE) and new variant Creutzfeld-Jakob disease (vCJD)), electro magnetic fields, physical or sexual abuse or molestation, terrorism, motor and professional indemnity.

Cancellation Rights

Customers defined as Consumers by the Financial Conduct Authority have the right to cancel the policy during a period of 14 days from the day of purchase of the contract or the day on which you receive your policy documentation, whichever is later. If you wish to do so after the insurance cover has already commenced, you will be entitled to a refund of the premium calculated in accordance with the Cancellation Condition set out in the policy wording.
